The Sponsor will be invoiced **NET30** to their preference of email or fax by the **1st Day of the Month Prior to Publication**. **Example:** An Sponsor would be invoiced by January 1st for a February Ad Placement. **Full Payment is due by the 10th Day of the Month of Publication**. If payment is not received by the 10th of the month the ad is to be published, the Sponsor will be contacted to arrange alternate payment details and confirm the rest of the advertising agreement.
